pH: 5.6 / VISCOSITIES: 1M at RT: 41,000 mPa.s Brookfield LV4-6 /

Recovery at RT (after 1M at 45°C): 42,000 mPa.s Brookfield LV4-6.

STABILITY: 1M at RT, 45°C & cycles -5°C/+40°C.

FORMULATION ADVICES: Laboratory scale - 300 g - Silverson

Weigh phase A in a beaker and mix evenly. Place phase B in the tank and mix with the defloculator (1 minute at 3000 rpm) then use the anchor (15 minutes, 50 rpm). Add phase A into B, evacuate and start homogenization (4 min, 4000 rpm), then mix with the anchor for 20 minutes at 50 rpm. Add phase C, mix for 15 minutes at 50 rpm. Add phase D and homogenize.

This mask refreshes your skin by providing simultaneously very light & smooth skin feel. A joyful feeling will be perceived when applying this product!
