**STABILITY:** 1M at RT, 45°C, -18°C & after -5°C/+40°C cycles.

**FORMULATION ADVICES: Laboratory Scale - 300 g - Silverson**

Weigh phase A in a beaker, do homogenization by Silverson at 4000rpm for 4 minutes. In another beaker, add phase C into phase B, mix well. Add phase A into phase B+C, do homogenization by Silverson at 4000 rpm for 4 minutes. Continue to stir the batch with an anchor stirrer at 180 rpm, add ingredients in phase D into the batch one by one, and stir till uniform.
